A strong regional economy with resilient, connected communities and a better quality of life, for all.

Canterbury Mayoral Forum achievements 2016–19

1. This report provides a summary of progress and achievements of the Canterbury Mayoral Forum during the 2016–19 local government term.

Regional forums

- 2. The Canterbury Local Authorities' Triennial Agreement 2017–19 mandates the work of the Canterbury Mayoral Forum, Chief Executives Forum, Policy Forum and other regional and sub-regional forums and working groups (see Appendix 1). Regional forums generally meet quarterly.
- 3. In 2017, the Chief Executives Forum established two additional regional forums (Corporate Forum, Operations Forum) to co-ordinate the activities of regional working groups. The Corporate and Operations Forums are proving to be a useful vehicle for sharing information, resources and capability between larger and smaller councils across the region.
- 4. As agreed in the Mayoral Forum Charter of Purpose, Environment Canterbury hosts a permanent regional forums secretariat hosted by Environment Canterbury: 2 FTE staff (funded through the regional general rate) and a CREDS Project Manager (fixed term, funded by a grant from the Provincial Growth Fund until December 2020).

Work programme

- 5. In February 2017, the Mayoral Forum approved a three-year work programme. The Chief Executives Forum oversees its implementation and reports quarterly to the Mayoral Forum.
- 6. The following projects are complete or will be complete by December 2019:
 - collaboration on development of 2018–21 Long-term Plans
 - integrated, multi-modal regional land transport planning and investment
 - a stocktake (with NZTA) of the resilience of the roading network in Canterbury
 - research to understand visitor transport flows across the South Island
 - establishment of a South Island Regional Transport Chairs network
 - identifying and mapping remaining gaps in mobile and broadband coverage in Canterbury
 - gathering and publishing stories about uptake and use of digital technologies to improve productivity in rural Canterbury

- expanding the Job Ready programme to mentor international student graduates into jobs in export-facing businesses across the region (with ChristchurchNZ)
- developing the 'Canterbury story' with a web-based library of open source images, videos and other marketing assets (with ChristchurchNZ)
- developing a South Island major events web tool to support co-ordination and marketing of major events (with ChristchurchNZ)
- investigating the business case for reintroducing rail passenger services south of Christchurch
- participating in Immigration New Zealand's *Welcoming Communities* pilot programme (Ashburton and Selwyn District Councils)
- investigation of opportunities to increase consistency of engineering standards across the region
- investigation of options for collaboration in valuation and rating services.
- 7. The following projects have become incorporated into "business as usual":
 - health and safety collaboration
 - collaboration on stormwater management planning and consenting
 - co-ordination of natural hazard risk management
 - continuing to build on the Canterbury Maps shared service
 - collaboration in procurement and contract management
 - contaminated land shared services
 - regional economic development indicators monitoring
 - regional leadership and support for strategic information and records management
 - building control and regulatory co-ordination
 - collaborative Resource Management Act planning and decision making.
- 8. The following major, multi-year projects will continue into the 2019–22 local government term.
 - In May 2019, the Mayoral Forum signed off on a review of the CWMS and agreed goals for 2025 and 2030. Environment Canterbury will lead development of an implementation plan (with resource implications), to inform development of councils' annual plans for 2020/21 and Long-term Plans for 2021–28.
 - ChristchurchNZ and the University of Canterbury are delivering a multi-year project to boost value-added production focused on food, fibre and agritech and high-value manufacturing.
 - With the agreement of all South Island Mayors and Chairs, we are developing a South Island Destination Management Plan for sustainable tourism, with support from the Ministry of Business, Innovation and Employment (MBIE), the Department of Conservation, the New Zealand Transport Agency (NZTA) and Tourism New Zealand.
 - The Canterbury Drinking Water Reference Group co-ordinated a strategic assessment of drinking-water supplies and is supporting the Mayoral Forum to respond to the Government's 3 Waters reform proposals as these emerge.
 - Aoraki Development's MynextMove youth transitions programme is well established in South Canterbury. We continue to explore opportunities to adapt this for delivery in other parts of the region.
 - ChristchurchNZ along with the University of Canterbury and Lincoln University will continue to resource a more specific Job Ready programme over the next two years that will mentor international student graduates into jobs. A work integrated learning model programme is being developed which will eventually replace Job Ready.

Leading regional development in Canterbury

- 9. The Mayoral Forum first launched the Canterbury Regional Economic Development Strategy (CREDS) in August 2015, and launched a refreshed strategy for the 2016–19 local government term in June 2017.
- 10. In the 2016–19 local government term, the Mayoral Forum secured central government funding of \$2.8m from the Regional Growth Programme (2017) and Provincial Growth Fund (2018–19).

In addition, funding applications to the Provincial Growth Fund have been submitted for major infrastructure projects in Timaru, Hurunui and Kaikōura Districts.

- 11. The Mayoral Forum has also supported and helped leverage funding to Canterbury councils from the Tourism Infrastructure Fund (TIF). The Ashburton, Hurunui, Kaikōura, Mackenzie, Selwyn, Timaru, Waimakariri and Waitaki District Councils and the Christchurch City Council secured a total of \$6,134,543 in Funding Rounds 1–3. Applications for Funding Round 4 opened on 1 August 2019.
- 12. In this local government term, the Mayoral Forum has supported successful Provincial Growth Fund applications by the Kaikōura, Ashburton, Mackenzie and Waitaki District Councils to a total of \$1,185,798.
- 13. In January 2018, the Mayoral Forum supported an application by the Church Property Trustees to the Lottery Significant Projects Fund for assistance with the reinstatement of Christchurch Cathedral. Lotteries funding of \$6m was committed in June 2018.
- 14. The Mayoral Forum has agreed in principle to frame the next iteration of the CREDS around the 'four wellbeings' (environmental, economic, social and cultural) and the 'four capitals' of

the Treasury's Living Standards Framework (natural capital, financial/physical capital, human capital, social capital).

Adaptation to climate change

15. In May 2017, the Chief Executives Forum established a regional Climate Change Working Group. Since February 2019 this has been supplemented and supported by a mayoral Climate Change Steering Group.

Supporting global awareness, tourism and trade

- 16. Since 2016, the Mayoral Forum has supported the University of Canterbury with applications to the Prime Minister's Scholarship for Asia for a programme in which students visit Peking University in Beijing and undertake group research projects. This has delivered reports for the Mayoral Forum on:
 - the different ways young Chinese 'free and independent' travellers hear about and find information on New Zealand and Canterbury, and the online channels they prefer to use
 - migration intentions of young, highly skilled Chinese students
 - food and beverage preferences of young Chinese visitors to New Zealand
 - perceptions of safety by prospective young Chinese visitors.
- 17. Education partnerships are in place between Canterbury and Nagano Prefecture, Japan, with 70 students from the University of Nagano arriving in June 2019 for three-week placements at Lincoln University and Ara Institute. The Mayoral Forum has been investigating options to develop and extend Canterbury's relationship with Nagano Prefecture, 'region-to-region'.

Standing together for Canterbury

- 18. The Canterbury Policy Forum monitors central government policy and regulatory initiatives impacting on Canterbury and co-ordinates the development of regional submissions. Joint advocacy ('one strong voice for Canterbury') has been a strength of the Mayoral Forum.
- 19. The following table summarises Mayoral Forum engagement and advocacy since local body elections in October 2016.
