### **CANTERBURY POLICY FORUM**

The Canterbury Policy Forum met on 7 July 2017.

- The Forum agreed draft terms of reference for a regional climate change working group. To provide broad perspectives on the issues, representatives on the group will come from engineering/operations, policy, communications and science disciplines.
- Members of the Forum strongly endorsed the value and effectiveness of the regional submissions process in response to a review of regional submissions and advocacy letters from the Mayoral Forum.
- Environment Canterbury shared its analysis of the impact of the Resource Legislation Amendment Act
- The Forum agreed to develop a regional submission on the NES Outdoor Storage of Tyres, led by Environment Canterbury.
- David Ward shared Selwyn District Council's experience of its District Plan review.
- Nicole Randall invited Forum members to be part of the Christchurch City Council Centre of Excellence for Quality Advice programme.
- An update about the Canterbury Regional Economic Development Strategy included detail about the \$2.185 million received from central government's Regional Growth Programme for 11 CREDS accelerator projects.
- Updates were provided on the Canterbury Water Management Strategy, national water initiatives, freedom camping, Regional Pest Management Plan review, Braided Rivers Management project, Regional Transport and the Canterbury Planning Managers Group.
